Minutes of the Meeting held 24th September 2014

Minutes of last meeting: accepted

Matters Arising: none (items dealt with on the Agenda)

Correspondence: Mike Otter read two letters of thanks from two students who had been given exhibitions of £100 each. (Liam Roberts and Jane Coup)

Financial Report: Phil Hamman reported on the progress made in changing the existing 'Exhibition shares' to 'Ethical shares'. He explained that not all shares could be changed as a portion is under the auspices of the Blackburn Diocese. He presented the figures to the committee and answered questions concerning the amount of interest raised. (Please see attached Financial statement produced.)

It was agreed that the sum of £1,500 be distributed as is laid down in the Trust deed.

1/5 to be used at the Foundation's discretion (£300.00)

The sum of £200.00 be distributed to the Lord Robens and L& B prize winners.

£100.00 each with the remainder to be decided.

Award of the Lord Robens and Leyland & Birmingham Rubber prizes

Members had received copies of the academic and personal statements of candidates nominated for the prizes together with short comments supporting them from the Heads of



House. Jonathan Morgan also presented the Foundation members with additional information about each nominee.

After discussion it was decided that:

Holly Jackson be awarded the Lord Robens Prize for her amazing academic achievement of 14 A* grades and her involvement within school.

Ellie Gamble be awarded the L&B prize. Ellie had made a contribution both to school and community as well as her achievements academically.

Two additional prizes were awarded to Bethan Gardner and Mark Dempsey (£25.00 each)

Jo Venn Prize (2015)

There was a short discussion with regard to the award. It was decided that a cup be awarded and engraved. M Otter to bring samples to the March meeting for final decision.
